HPLC

The students and faculty would work on HPLC quantitative determination of plasma levels of drugs and their metabolites for project and research works respectively. This is of special importance during the development of new drugs and for monitoring therapy. This would be applicable to a much greater variety of mixtures, including non-volatile molecules. This chromatographic techniques used for method development and simultaneous estimation of drugs by reverse phase mode and it would play an important role in finding and isolating the active ingredients, in quality control of raw materials getting from labs. It is one of the choices for analyzing materials the wide range of organic compounds. The sample given by 2nd Party for the evaluation of metabolites.

UV-VISIBLE

UV spectroscopy is an analytical tool to determine the purity of the analyte and it does not undergo decomposition. The qualitative analysis technique is used to perform quality control checks for raw material and biologically relevant compounds such as nucleic acids, DNA, and RNA. UV-visible spectroscopy is used to determine the concentration of a substance in a sample by measuring the absorbance of light at a specific wavelength. It helps to identify the presence of specific functional groups or chromophores in a compound based on characteristics absorption peaks. Faculty and students determine the concentration of active pharmaceutical ingredients in drug formulations ensuring product quality and consistency. The given sample is analysed by 1st party for further process.

DISSOLUTION APPARATUS

This is helpful in student projects that teaches theory and application by applying for evaluating solid and semi solid dosage forms as well as oral suspensions. It is utilized for testing the quality and consistency of drug products and used to monitor their stability over time, assessing whether changes in storage conditions affect drug release characteristics. It is applied for food and cosmetics, to assess the release of active ingredients from various products. LAMINAR AIRFLOW (LAF)

Laminar airflow (LAF) refers to the controlled, unidirectional airflow of highly filtered air in a confined area, typically within a laminar flow hood or cabinet. Laminar airflow is crucial in aseptic processing environments, where it provides a sterile workspace for the filling and packaging of pharmaceutical products, ensuring product safety and quality. It is used by faculty for the research purpose to conduct experiments and tests on sensitive materials, where contamination could affect results, and also used to teach students about sterile technique and microbiological procedures, making it a fundamental tool in pharmaceuticals, healthcare, research, and manufacturing.

Tablet Disintegration testing is crucial to ensure that tablets and capsules break down in to small pieces properly under suitable pH conditions, allowing the active ingredients to be absorbed.
