Subsequently, the institution was granted Autonomous Status by UGC, New Delhi and JNTU-GV for the period from 2025 to 2035, enabling it to design and implement its own curriculum, academic regulations, and assessment systems to meet evolving industry and academic requirements.
- He invited the esteemed members of the Academic Council to provide their valuable suggestions and recommendations on the course structure, academic regulations, examination pattern, and strategic initiatives for the holistic and sustainable development of the institution, ensuring that the autonomous framework contributes effectively to academic quality and institutional growth.

- Introduction of Academic Council Members.

Member Suggestions

- The Dean of Academics extended a warm welcome to all the distinguished members of the Academic Council. The Council comprises eminent personalities with rich experience and expertise in various fields of pharmaceutical education, research, and industry. Their guidance is expected to play a pivotal role in the academic and institutional development of Avanathi Institute of Pharmaceutical Sciences (AIPS).
- It was affirmed that the institution continues to strictly follow the regulations and guidelines laid down by the Pharmacy Council of India (PCI) and Jawaharlal Nehru Technological

- The examination system, encompassing both Internal and External assessments, will continue to be conducted in accordance with University regulations, ensuring transparency, fairness, and academic rigor.
- The Council expressed confidence that with the collective expertise of its members, AIPS will continue to achieve excellence in pharmaceutical education, research, and innovation.

Item 3:

- **Presentation and approval of R25 Regulations for B. Pharm, M. Pharm, and Pharm D.**

Members Suggestions:

- Discussion Regarding skill oriented /mandatory courses relevant to current scenario.
- Consideration of MOOCS Courses for the students.
- Discussion about strict adherence to PCI and JNTU-GV Regulations during Regulations drafting.

Resolutions:

- The Chairperson of the Academic Council, in collaboration with the Dean of Academics, ensured to the council members that strict adherence has been made in accordance with PCI and JNTU-GV Regulations while drafting the Regulations of B.Pharm, M.Pharm and Pharm.D.
- **B Pharm R25 Regulation:** The course is a full-time program of four academic years, conducted semester mode, with each semester consisting of at least 100 working days.
- The curriculum includes theory, practical, and skill-based courses, and students must complete at least 150 hours of practical training after the second year in either hospital or community pharmacy, or in pharmaceutical or allied industries for a minimum of one month.
- Examinations are held at the end of each semester, with two opportunities per year (regular and supplementary). The exams include written papers, practical's, and viva voce. To be eligible to sit for exams, students must have at least 80% attendance in both theory and practical classes, certified by the head of the institution.
- Internal assessment is based on sessional marks, with 25 marks allotted for each subject in theory and practical. These marks are calculated from the best two out of three sessional exams, and practical marks also consider performance, records, and viva.
- To pass, students must secure at least 50% marks in each subject, including sessional marks.

Students who score 50% or above in all subjects in a single attempt are declared to have passed in First Class, while those who score 75% or above in any subject(s) in a single attempt are awarded Distinction.

- M Pharm R25 Regulation: The M.Pharm program is structured on a credit system. Each subject carries credits based on the number of lecture hours, practical hours, and tutorials. Students must earn the prescribed minimum credits in theory, practicals, and dissertation work to progress and complete the degree. Credits are distributed across core subjects, electives, skill-based modules, and research methodology, ensuring balanced exposure to advanced pharmaceutical sciences, clinical practice, and research.
- Examinations are conducted at the end of each part of the program. They include written papers, practicals, and viva voce, and are evaluated using a grading or marking system. Internal assessment marks are awarded based on sessional exams, practical performance, seminars, and dissertation progress. To pass, students must secure at least **50% marks in each subject including sessional marks**. Students who score 60% or above in all subjects in a single attempt are declared to have passed in First Class, while those who score 75% or above in any subject(s) in a single attempt are awarded Distinction.
- Pharm D R25 Regulation: The program is a six-year full-time course, consisting of five years of academic study followed by one year of internship or residency in a hospital.
- Admission to the course requires passing the 10+2 examination with Physics, Chemistry, and Biology or Mathematics along with English, or holding a D.Pharm qualification from a PCI- approved institution. The minimum age for admission is 17 years by December 31 of the admission year, and reservation of seats is provided as per government norms.
- The curriculum is structured on a credit system, where each subject carries credits based on the number of lecture hours, practical hours, and clinical training. Students must earn the prescribed minimum credits each year to progress to the next level. Credits are distributed across core pharmacy subjects, clinical pharmacy practice, pharmacology, pharmaceutical chemistry, pharmacotherapeutics, hospital pharmacy, and electives, ensuring balanced exposure to theory, practicals, and clinical skills.
- The final year consists of a compulsory internship or residency in a hospital, where students gain hands-on experience in patient care, clinical pharmacy services, and therapeutic decision-making.
- Examinations are conducted at the end of each academic year and include written papers,

practicals, and viva voce. Students must maintain at least 80% attendance in both theory and practical classes to be eligible for examinations, and internal assessment marks are awarded based on performance in sessional exams, practical work, and clinical records.

- To pass, students must secure at least 50% marks in each subject, including sessional marks. Students who score 60% or above in all subjects in a single attempt are declared to have passed in First Class, while those who score 75% or above in any subject(s) in a single attempt are awarded Distinction.
- On successful completion of the required credits, internship, and examinations, students are awarded the Pharm.D degree, which qualifies them to register as pharmacists and practice in clinical and community settings.
- After thorough deliberation and recognizing its relevance in these contributions enhance the academic processes and policies, the Academic Council members have unanimously approved these regulations.

- The following moderations may be considered in result processing for UG students' Regular Examinations:

Members Suggestions:

- The Dean–Academics briefed the Council members that the Examination Manual has been updated to incorporate all the procedures and guidelines issued by the Director of Evaluation, JNTU-GV, as per the Standard Operating Procedure (SoP) dated 20-01-2025 and 21-01-2025.
- The following types of moderation methods may be considered during result processing for B Pharm or Pharm D Regular Examinations:

2. Student Level Moderation or Adjustment or Grafting

- Subject Level Moderation: This is applied based on the overall pass percentage in a particular subject:
- If the pass percentage is between 30% and 50%, 3 marks are added to all students who appeared.
- If pass percentage is below 30%, 4 marks are added to all students who appeared.
- Student Level Moderation / Adjustment / Grafting:
- Applicable only when a student has failed in one theory subject and passed all other subjects in that semester.
- Marks from passed subjects are adjusted without altering original grades to help pass the failed subject, subject to the following constraints:
 1. Transferred marks **must not exceed 25% of the pass mark** in the failed subject.
 2. Transferred marks **must not exceed 1% of the total marks** secured in the remaining theory subjects.
 3. The **minimum of the above two values** is considered as the **maximum transferable marks**.
 4. Applicable **only for Regular Theory Examinations**.
 5. **Not applicable** to Supplementary or PG Examinations.

Eligibility Conditions for Student-Level Moderation: Student must have

1. Passed all subjects **except one theory subject**.
2. Required marks from the passed subject(s) can be transferred **without grade change**.
3. Transferable marks follow the limits as stated above.

4. Result Processing Procedure

- Number of registrations = Number of answer booklets scanned + Number of entries in Lab OMR scanned + Number of registrations in Mandatory courses + Number of registrations in NPTEL courses + Number of absentees in D forms
- If there is any issue, verify in the following order:
 1. D-form
 2. NPTEL Certificates
 3. Lab Submissions
 4. Theory Booklets Scanned

- The members thoroughly reviewed the entire result processing procedures and moderation guidelines issued by JNTU-GV.
- Members expressed satisfaction, acknowledging the measures as student-friendly and academically sound.
- The Council approved the incorporation of all the above points into the Examination Manual.
- The procedures shall be implemented with immediate effect for all forthcoming Regular B Pharm and Pharm D examinations.

Item 5:

- Discuss and approve to establish a separate examination section with Bees Examination tool, Server System, Hardware, Security keys, Scanner, QR code integration, OMR Key license and Antivirus etc.

Members Suggestions:

- The Dean–Academics emphasized the strategic importance of a standalone examination section to uphold autonomy, streamline operations, and ensure timely result processing.
- The Controller of Examinations recommended deploying the Bees Examination Tool for secure question paper handling, evaluation workflows, and audit trails.
- The IT Coordinator proposed provisioning a dedicated server system with robust hardware, encrypted security keys, and licensed antivirus protection to safeguard examination data.
- Faculty members suggested integrating QR code tracking and OMR key licensing to enhance transparency and reduce manual errors in evaluation.
- The Administrative Officer advised incorporating high-speed scanners and backup systems to support bulk processing of theory booklets and lab submissions.
- Members unanimously agreed that the infrastructure must comply with JNTU-GV's Standard Operating Procedures (SoP) and be scalable for future upgrades.

 - **Ethics and Universal Human Values in 1st Year, 2nd Semester** – to instill ethical reasoning, empathy, and civic responsibility in future healthcare professionals.

Resolutions:

- The Academic Council resolved to **approve the proposed** course structure for the 1st Year – 1st and 2nd Semesters of the B.Pharm programme, incorporating the recommended skill and value-based modules.

Item 8:

Members' suggestions:

- All postgraduate (PG) programmes shall strictly adhere to the academic regulations prescribed by the JNTU-GV and PCI to ensure uniformity, compliance, and academic integrity.
- Mandatory courses should be integrated across all branches of M.Pharm to foster foundational competencies in research methodology and innovation.
- Inclusion of interdisciplinary and skill-based modules that align with national education policy (NEP) guidelines and PCI recommendations.
- Emphasis on outcome-based education (OBE) and continuous internal assessment (CIA) mechanisms to improve academic rigor and student engagement.

Resolutions:

- It was unanimously resolved and communicated to all Board of Studies (BoS) Chairpersons that the university's academic regulations shall be applicable to all PG programmes without

exception, ensuring consistency in curriculum delivery and evaluation standards.

- It was resolved to introduce the following mandatory courses across all M.Pharm specializations:
 - a) **Research Paper Writing in the 1st Year, 1st Semester** – to equip students with scientific writing skills, literature review techniques, and publication ethics.
 - b) **Entrepreneurship Management in the 1st Year, 2nd Semester** – to cultivate entrepreneurial mind-set, business planning acumen, and innovation-driven thinking among pharmacy graduates.

Item 9:

- Presentation and approval of Course Structure of I Pharm D.

Members Suggestions:

- A credit-based system was proposed and endorsed for the academic year 2025–2026, with a total of 36 credits allocated for the first year of the Pharm D programme. This structure is designed to balance theoretical instruction, practical exposure, and skill development.
- Members recommended the integration of skill-oriented courses to strengthen communication and interpersonal abilities essential for clinical practice:
 - **Communication Skills** to be introduced in the **1st Year**, focusing on patient interaction, professional etiquette, documentation, and counseling techniques.

Resolutions:

- The Academic Council resolved and formally communicated to all concerned Board of Studies (BoS) Chairpersons that the university's academic regulations shall be uniformly applied to all Pharm.D programmes, ensuring regulatory compliance and curricular coherence.
- It was resolved to introduce a credit-based framework for the Pharm.D programme beginning with the academic year 2025–2026, assigning 36 credits for the first year, distributed across core subjects, practicals, and skill modules.
